We are pleased to enclose Commission Regulation (EC) No 924/2004 of 29 April 2004 amending Council Regulation (EC) No 1210/2003 of 7 July 2003 concerning certain specific restrictions on economic and financial relations with Iraq.

The purpose of the Regulation of 29 April 2004 is to amend Annexe IV to Regulation (EC) No 1210/2003 by adding several names of natural persons to the list of persons, bodies and entities associated with the regime of former President Saddam Hussein covered by the freezing of funds and economic resources under Article 4 of that Regulation.

We also draw your attention to the fact that Annexe V (list of competent authorities) to Regulation (EC) No 1210/2003 has been amended by Commission Regulation (EC) No 2204/2003 of 17 December 2003.

We remind you that you are required to immediately report any relevant information relating to the enclosed Regulations to the Commission de Surveillance du Secteur Financier, who will forward the information to the Ministry of Foreign Affairs, Division of International Economic Relations, as well as to the Ministry of Finance.

These Regulations came into force on 30 April 2004 and 19 December 2003 respectively.

- Annex IV to Regulation (EC) No 1210/2003 lists the (1)natural and legal persons, bodies or entities associated with the regime of former President Saddam Hussein covered by the freezing of funds and economic resources under that Regulation.
- On 7 April 2004, the Sanctions Committee of the (2)United Nations Security Council decided to amend the list comprising Saddam Hussein and other senior officials of the former Iraqi regime, their immediate family members and the entities owned or controlled by them

- or by persons acting on their behalf or at their direction, to whom the freezing of funds and economic resources should apply. Therefore, Annex IV should be amended accordingly.
- (3) In order to ensure that the measures provided for in this Regulation are effective, this Regulation must enter into force immediately,

HAS ADOPTED THIS REGULATION:

Article 1

Annex IV to Regulation (EC) No 1210/2003 is hereby amended in accordance with the Annex to this Regulation.
