# INTERNATIONAL REGULATION

#### DIRECTIVE 2007/16/EC OF 19 MARCH 2007

Commission Directive 2007/16/EC of 19 March 2007 implementing Council Directive 85/611/EEC on the coordination of laws, regulations and administrative provisions relating to undertakings for collective investment in transferable securities (UCITS) as regards the clarification of certain definitions

Guidelines of the Committee of European Securities Regulators (CESR) regarding eligible assets of UCITS

Directive 2007/16/EC of 19 March 2007, available on the website of the European Commission (<u>http://ec.europa.eu/internal\_market/securities/docs/ucits/dir\_2007\_03\_19\_en.pdf</u>), a Level 2 Directive of the Lamfalussy procedure, aims at clarifying certain definitions of the amended UCITS Directive 85/611/EEC with a view to ensuring a uniform application of this Directive.

Directive 2007/16/EC includes in particular specifications on the following eligible assets: transferable securities, money market instruments, liquid financial assets, transferable securities embedding derivatives, techniques and instruments and UCITS replicating a financial index.

This Directive shall be implemented on 23 March 2008 at the latest and the provisions implementing the Directive shall apply from 23 July 2008.

On 19 March 2007 as well, the Committee of European Securities Regulators (CESR) issued in this same context guidelines concerning eligible assets of UCITS (<u>http://www.cesr-eu.org</u>, reference 07-044). These Lamfalussy Level 3 guidelines include additional specifications concerning financial instruments eligible for UCITS subject to the amended UCITS Directive 85/611/EEC.

Directive 2007/16/EC and the CESR guidelines are both based on CESR's advice published in January 2006, which included Level 2 and Level 3 measures. This CESR advice was published on 26 January 2006 on the CESR website, http://www.cesr-eu.org, reference 06-005.

Directive 2007/16/EC and the CESR guidelines constitute a single package of measures and CESR members shall apply both sets of rules simultaneously. To this effect, it is foreseen that the CESR guidelines must be implemented on the same date than Directive 2007/16/EC, i.e. on 23 March 2008 at the latest.

The aim of the texts is to eliminate the uncertainties in determining whether an UCITS can invest in certain financial instruments or not.



## STATISTICS

#### BANKS

#### Slight decrease in the banks' balance sheet total as at 28 February 2007

As at 28 February 2007, the balance sheet total of the banks established in Luxembourg amounted to EUR 846.572 billion as compared to EUR 861.187 billion as at 31 January 2007, which represents a 1.7% decrease.

Following the merger by takeover of Banca Nazionale del Lavoro International S.A. by BNP Paribas Luxembourg, the number of banks registered on the official list as at 31 March 2007 reached 155 entities.

#### PROFESSIONALS OF THE FINANCIAL SECTOR (PFS)

#### Slight increase in the balance sheet total as at 28 February 2007

The balance sheet total of all the PFS amounted to EUR 74.280 billion as at 28 February 2007 (202 active businesses at this date) against EUR 73.215 billion in the previous month (199 active businesses), which represents a 1.45 % growth over one month.

Provisional net profit of these 202 financial players reached EUR 92.40 million as at 28 February 2007 against EUR 59.17 million as at 28 February 2006 (191 active businesses).

## Approval of five new management companies under chapter 13 of the law of 20 December 2002 concerning undertakings for collective investment

The CSSF informs that five new management companies have been registered on the official list of management companies governed by chapter 13 of the law of 20 December 2002 concerning undertakings for collective investment, namely:

- EFG Asset Management S.A.
- Europa Invest S.A.
- Hansa-Nord-Lux Managementgesellschaft
- Kaltchuga Capital Management S.A.
- Smart Asset Management (Luxembourg) S.A.

These management companies are exclusively active in the field of collective management.

Following these approvals, the number of management companies governed by chapter 13 of the law of 20 December 2002 concerning undertakings for collective investment and allowed to benefit from the European passport since 13 February 2004 by way of free establishment or free provision of services in a EU Member State amounted to 165 as at 10 April 2007.

#### PENSION FUNDS, SICARS AND AUTHORISED SECURITISATION UNDERTAKINGS

#### Approval of four new SICARs

Four new <u>SICARs</u> have been registered during the month of February 2007 on the official list of SICARs governed by the law of 15 June 2004 relating to investment companies in risk capital (SICAR). The number of SICARs registered on the official list amounted to 123 entities as at 10 April 2007.

The four newly authorised entities are:

- Lehman Brothers Merchant Banking Partners IV (Europe) S.C.A., Sicar
- Novenergia II-Energy & Environment (SCA), Sicar
- MM Mezzanine SCS, Sicar
- Redline Capital Partners Sicar S.A.

As at 31 March 2007, the number of <u>securitisation undertakings authorised</u> by the CSSF in accordance with the law of 22 March 2004 on securitisation amounted to 12 entities as compared to 11 at 31 December 2006.

As at 31 March 2007, 14 pension funds in the form of pension savings companies with variable capital (sepcav) and pension savings associations (assep) were registered on the official list of pension funds subject to the law of 13 July 2005.

The number of professionals authorised to act as <u>liability managers</u> for pension funds subject to the law of 13 July 2005 amounted to 12 as at 31 March 2007.


#### ■ GLOBAL SITUATION OF UNDERTAKINGS FOR COLLECTIVE INVESTMENT AT THE END OF FEBRUARY 2007

Press release of 2 April 2007

As at 28 February 2007, total net assets of undertakings for collective investment reached EUR 1,908.707 billion compared to EUR 1,895.810 billion as at 31 January 2007. The Luxembourg undertakings for collective investment sector increased by 0.68% compared to January 2007. This growth is due to the inflow of new capital. In February 2007, the sector increased by 3.46% compared to 31 December 2006 when total net assets amounted to EUR 1,844.850 billion. Over the last twelve months, the volume of net assets rose by 16.52%.

During the month of February 2007, net capital investment amounted to EUR 29.083 billion. Compared to 31 December 2006, net capital investment totalled EUR 59.832 billion.

The number of undertakings for collective investment taken into consideration totals 2,278 as against 2,260 in the previous month. A total of 1,401 UCIs have adopted an umbrella structure, which represents 8,760 sub-funds. When adding the 877 UCIs with a traditional structure to the previous figure, a total of 9,637 sub-funds are active in the financial centre.
